To whom it concerns at the aforementioned agencies (addressees):

On 8/22/2014:

while I was acting as attorney-in-fact AND trying to perfect and prepare service of subpoenas by purchasing the seal of the clerk (mind you I had no intention to serve subpoenas until the clerks on duty denied me the right to the seal), Mercer County Sheriff's Officer Parent, and three other officers arrested me as I attempted to leave the court house at 175 South Broad Street. Officer Parent continued to harass and ultimately assault and batter me when he pushed me away from the exit, when I attempted to leave after confirming I was not under-arrest for any cognizable lawful probable cause issue. I recorded this interaction and the names of the other officers, I then reported the issue to the F.B.I. For further investigation.

Prior to leaving I had left the subpoenas with the clerk for service as was her responsibility as an employee of the court, who took receipt of the subpoenas, and pursuant my enhanced powers of service by the order of a Superior Court Judge from 2013 with regard to the relevant legal matter addressed in the subpoenas.

The clerk then tried to demand I take the subpoenas back into my possession, I then refused, especially since she presented one of the subjects Doug Meckel with the subpoenas (he was definitely served by the clerk).

On 8/25/2014:

Christopher Kenyon and the Mercer County Sheriff's Office committed mail fraud by returning the subpoena copies to me via U.S. Postal Mail. The letter states (in part):

"The enclosed documents were left in the main lobby of the Mercer County Civil Courthouse on Friday August 22, 2014, and are being returned to you. " "... Christopher Kenyon Chief Sheriff's Officer".

The above letter is known to me to be an act of mail fraud, because another state agency sent me a letter acknowledging receipt of the Subpoenas in a letter dated August 29, 2014.

Since I know I did not leave the subpoenas in the 1st Floor lobby, nor did I take possession of them after I left them in the custody of the clerk on the 2nd Floor.

I know with a 100% certainty, as attorney-in-fact, and as a witness-of-fact, and via recordings of the events, that the subpoenas were not left in the lobby by myself.

Further: I now demand that the Mercer County Sheriff's Office and the Superior Court of New Jersey impound and maintain the video records from the court house on 8/22/2014 as evidence in an ongoing criminal investigation, which I am executing pursuant my powers of prosecution under court rule 1:21, and the binding common-law and constitutional rights and authorities in my possession to pursue this matter via private attorney, with regard to the misdemeanor harassment (2C:33-4) that the letters and conduct of the Sheriff's Officers and the person(s) acting as clerk 8/22 and / or 8/25 represent as described previously in this letter. To be clear I find the conduct and the communications from the New Jersey Superior Court and Mercer County Sheriff's Office, to be shocking, alarming, annoying, and unnecessary. As such these acts are acts of criminal harassment. They will be prosecuted within the statute of limitations, and the investigation is now ongoing, locally and federally.

On 10/15/2014:

I was acting as attorney in fact at 400 Warren Street to serve copies of the Writ of Mandamus and Petition for Redress of Grievance, pursuant my right, authority, and privileges to do so visa vi the New Jersey State Constitution, Article I, paragraph 18, the court rules (1:5 et seq. 1:9 et seq.),; my special powers of service granted by court order and the authority and operation of law pursuant: the New Jersey Appellate Divisions: decisions in "Hawkins v. Harris (1995) & "Loigman v. Middletown", which create the legal foundation for my litigation privileges.

While at the court house Officer Bunchk and Gogan both stalked and harassed me without cause, interrupted my conversations with the clerk, and assaulted me with threats of removal from the court house, based on nothing but vague threats that I was taking too much time, or asking questions, or making demands that they personally were not happy with as non-parties, non-legal experts, observing my privileged conversations with the Clerk.

This too is criminal Harassment, and assault according to the statutes of New Jersey. I was threatened unnecessarily and I was again shocked, alarmed and annoyed.

PLEASE TAKE IMMEDIATE REMEDIAL ACTION, AND CEASE FURTHER UNWARRANTED HARRASSMENT AND/OR ESCORTING OF MY LEGAL PERSONS IN THE FUTURE OR I WILL EXERCISE MY RIGHT, AUTHORITY, AND POWERS TO LAWFULLY ARREST ANY PERSONS WHO ATTEMPT TO HARASS, ASSAULT, OR OBSTRUCT THE INTERESTS OF JUSTICE RELATED TO THE LAW OF MY CASES BEFORE THE SUPERIOR COURT OF NEW JERSEY.

PLEASE UNDERSTAND AND CONSTRUE THIS CORRESPONDENCE AS THE LAST WARNING OF MY RIGHT TO CIVILLY AND LAWFULLY ENFORCE MY RIGHTS AS A CITIZEN OF NEW JERSEY WITH ARREST POWERS.

To be Clear: Nothing in this letter is intended as a threat against any person, it is only intended to enforce my legal rights in my legal capacities within this jurisdiction.

Further: Please accommodate my reasonable request that the Mercer County Sheriff's Office cease escorting me when I appear in court as is my right. I make this request pursuant the Federal "American with Disabilities Act" as a permanently disabled person diagnosed with Post-Traumatic-Stress Disorder (in part attributed to past acts and conduct of the Mercer County Sheriff's Office, which includes past false statements from the office, and multiple warrantless and/or unexplained arrests).

FURTHER CRIMINAL CONDUCT BY THE M.S.C.O. OR SUPERIOR COURT WILL NOT BE TOLERATED WITHOUT A LEGAL RESPONSE FROM IN ONE OR ALL OF MY LEGAL CAPACITIES.
